From the CEO

In previous newsletters we have outlined a range of initiatives that we have been working on to improve the efficiency and effectiveness of the apprenticeship training systems we are responsible for. These initiatives have been partly driven by changes to Government funding and partly by Government expectation of better performance. Ironically, some of these initiatives have increased ITO expenditure, while Government funding has reduced.

One of the main initiatives to improve trainee progression has been the introduction of a new system for plumbing and gasfitting apprentices involving one week block courses every 17 weeks. We have also scheduled a much greater number of these one week block courses to enable those trainees who have fallen behind to catch up. This has resulted in a 35% increase in block courses in 2011, which will contribute to an almost doubling in National Certificate completions for the year.

A major focus on getting more roofing assessments completed, and much faster assessment turnaround times, is resulting in a record number of roofing trainees completing their qualifications. Other improvements to the training delivery systems have also had a positive effect on completion rates.



The graphs below show the large growth in completion rates, as well as growth in credit achievement which is a good indicator of how well trainees are progressing through their qualifications.

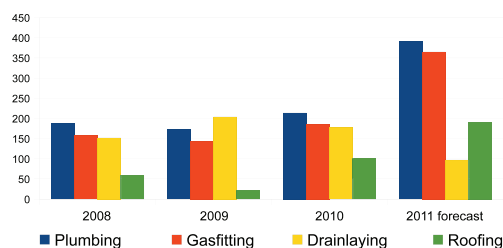
The cost of the increase in block courses has contributed to an expected year end loss for the ITO of around \$1 million. In order to reduce

the loss we have cut costs in a number of ways, including postponing some block courses scheduled for the latter part of the year. We regret having to take this step, and apologise to those who are affected. We hope that those affected will understand why the postponement has been necessary.

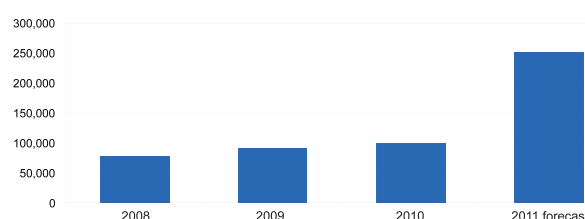
Fortunately the ITO is able to sustain the forecast loss in 2011, and cost saving measures being implemented are forecast to result in break even or better for 2012 and beyond. It is also inevitable that some fee increases will be necessary. We will continue to seek stakeholder input to ensure that any changes we do introduce are supported by industry and other stakeholders, and don't compromise the high quality apprenticeship training systems currently in place.

World skills competition

World skills competition was held in London in October this year. 51 countries attended and participated in 46 different skill competitions. This was a massive event with 950 competitors, 1000 judges and 200,000 visitors.



New Zealand's plumbing competitor was Scott Nicholson. Scott had won the regional and national competitions, attended two world skills New Zealand (Tool Blacks) team building camps, and

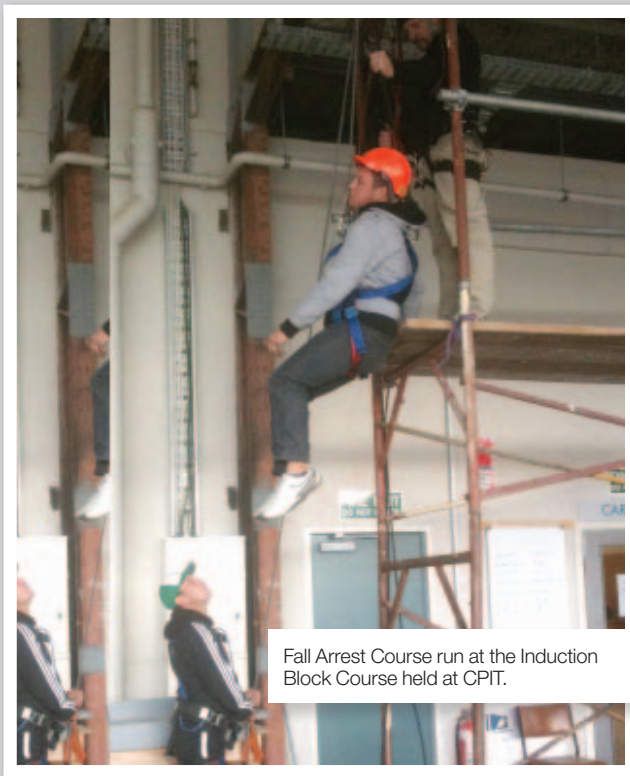
competed in the global skills challenge in Australia prior to attending the world skills competition in London.

Just like the Olympics, world skills has an opening ceremony. The New Zealand team were given strict instructions not to hold up the procession to perform a Haka, so of course right in the middle of the procession the Tool Blacks performed a fantastic Haka, much to the enjoyment of the crowd.

This year was the first time there was a team challenge. Four teams were picked at random to install a solar water heating system. Many of the competitors didn't speak English, which made this an even greater challenge. Scott's team won the team challenge which was a fantastic effort and a highlight of the competition for New Zealand.

To cap off a very enjoyable and successful competition officials from the World Plumbing Council presented the competitors and judges with engraved WPC medallions in recognition of their voluntary work in promoting a high standard of workmanship in the trade, the importance of public health and the environmental roles of the plumbing industry.

New system puts the pressure on

In our last newsletter we acknowledged that there was some dissatisfaction with the new system for plumbing and gasfitting block courses, and that we were working with training providers to address issues of concern.

At the same time many employers and trainees are telling us they really like the new one week block course system. However, some issues continue to be of concern to apprentices and employers, particularly in the Waikato, and we are working closely with WINTEC to sort out these issues. The new system has taken a bit of getting used to for everyone involved, including the polytechnics and other training providers, however the outstanding results that are generally being achieved

certainly confirm that this new system is a significant improvement over the old.

At the heart of the issues is the increased pressure that is being applied, not only to apprentices, but also to the polytechnics and the whole learning system. Although this pressure is creating some discomfort, we need to think about the great results that are being achieved, which is after all what everyone wants.

We know it is frustrating for everyone getting used to the new systems and ironing out the glitches, please bear with us, we are working hard to make it work smoothly. Complaint to NZQA

Some readers will be aware of recent media reports about a New Zealand Qualifications Authority (NZQA) investigation into the assessment of 23 trainees who undertook Stage 3 plumbing and gasfitting block courses at Manukau Institute of Technology (MIT) in 2010. The investigation arose from a complaint that alleged the Plumbing, Gasfitting, Drainlaying and Roofing Industry Training Organisation (PGDRITO) supplied invalid assessment material to MIT.

The NZQA investigation has concluded that the MIT assessment materials did not fully assess all of the required unit standards on the block course. However NZQA found that although the ITO's records relating to the Stage 3 assessments were not adequate, there was no evidence to suggest deliberate falsification of results. NZQA required the ITO to review assessment records for each student and arrange reassessment to address any gaps identified.

We accept NZQA's findings and emphasise that the situation is an anomaly created by a one-off set of circumstances. The inconsistencies in block course assessment materials stemmed from the transfer of 23 apprentices who started their training in a non-ITO training system and were moved into the new national system at MIT for their final year. Compounding the situation, MIT had not previously delivered the Stage 3 block courses for the ITO.

We acknowledge that the transition from different assessment systems was not managed as well as it should have been, with the unfortunate result that some of the block course assessment tasks were not adequate. We have apologised to the apprentices, and their employers, for any uncertainty and inconvenience in situations where further assessment is required.

The apprentices concerned have completed all of their training, worked in apprenticeships for at least four years and already undergone a comprehensive assessment process. It is a very unfortunate set of circumstances and we have assured those concerned that any reassessment procedures required will be at no additional cost and with a minimum of inconvenience.

We are currently working with NZQA to ensure there is confidence and certainty moving forward, including a review of the ITO's new nationally-consistent block course assessment standards.

We are obviously very disappointed with the outcome of the NZQA investigation, however we recognise the importance of ensuring confidence in quality assurance systems and it is important that any concerns are quickly and comprehensively resolved.

It would be particularly disappointing if media coverage of the NZQA investigation were to overshadow the significant progress that PDGRITO has made this year in its goal to improve the performance of the sector. As a result of a concerted focus on 'getting trained and getting training completed' record levels of training have been undertaken in 2011. The ITO has purchased 293 weeks of block courses in 2011 from contracted providers, up from 217 in 2010. As a result National Certificate completions in 2011 will be around twice the number achieved in 2010.
